- ⁴ Day "D" means a calendar day, excluding electronic service outages, where a SEPA payment / SEPA standing order has been submitted to the Bank via MOJA ČSOB, SmartBanking and ČSOB API.

Day "D" means a working day if the payment order has been submitted to the Bank via the electronic banking services ČSOB BusinessBanking lite, ČSOB BusinessBanking, ČSOB MultiCash 24 or swift messages MT101.

⁵ A non-working day is a day that is a weekend (Saturday, Sunday) or a public holiday.

If the payer submits a payment order after the cut-off time set by the Bank, the amount of the payment transaction will be debited the following working or calendar day, depending on the type of payment transaction and the method of submission of the payment order.

ČSOB is not responsible for cut-off times and processing method of payment transaction in other banks unless a special regulation stipulates otherwise. This information about cut-off times for payment transactions in ČSOB, a. s. are **effective from 07.10.2024** and replaces the previous document for cut-off times for payment transactions, which was effective from 07.12.2022.
